# **SPOTLIGHT ON LAND TRUST HOLDINGS** The Graham Brush Preserve

This relatively remote 40-acre parcel is located off of Wintergreen Lane, on land previously owned by former land trust board member Jed Strukus. The Warren Land Trust purchased the property from Mr. Strukus in 2002 with partial funding from the State of Connecticut's Open Space & Watershed Acquisition Grant Program, and then provided a conservation easement on the parcel to the State of Connecticut as part of the grant requirements. This acquisition marked the first time that the land trust had availed itself of a state grant to obtain a parcel of land, and successful navigation of the complicated grant process demonstrated our organization's growing sophistication and capacity.



The land is at one of the highest points in the state and is mostly heavy hardwood forest intercut with white pine. The Graham Brush Preserve is not to be confused with the Graham Brush Parcels - four smaller conservation easements located near Lake Waramaug donated by Mr. Brush. The Graham Brush Preserve was named after this key land trust supporter, who was among the organization's original directors. Shortly after purchase of the land, land trust founder Dorothy Maier contacted Kay Brush, Mr. Brush's widow, and suggested that the Warren Land Trust name the parcel after him. to honor his contributions "of time, ideas, money and easements'

### Warren Land Trust at the Fall Festival

In an interview, Tim offered many salient points about the Land Trust's mission. Tim remarked that "we have had the opportunity in Warren to grow responsibly while learning from surrounding towns' experiences." He also noted that the northwest corner of Connecticut has had the benefit of modest growth during the past thirty years, a pace that has allowed for balanced development.

Together with his wife Carla, Tim helps support a family farm that stresses planning and land conservation. He observed, "With the threat of family farms phasing out, we need to offer farmers an alternative to simply selling their land." Tim has been instrumental in helping the Land Trust remain mindful of such big-picture land-use issues. To this end, Tim has been a supporter of the Connecticut Farmland Trust. He also serves as the Warren Land Trust's liaison with the Lake Waramaug Task Force, with whom we share mutual interests. In short, Tim Angevine is an ideal advocate for the preservation of the environment and open spaces—a man for all seasons!
