### **SPOTLIGHT ON LAND TRUST HOLDINGS**

### The Podlaseck-Bryant Preserve

The Podlaseck-Bryant Preserve is a scenic 58.2 - acre parcel that has been under the purview of the Warren Land Trust since 2007. This conservation easement on Brick School Road received from Mark Podlaseck and Stephen Bryant complements natural resources important to our town. The Preserve abuts some 1100 acres of previously protected land, including Wyantenock State Forest, Kent Falls State Park and Weantinoge Heritage holdings. Together, these lands comprise an area of "Scenic Vistas and Land of Potential Conservation Interest" singled out in town and state plans dating back to 1989.

The Preserve is comprised of two habitat groupings: stream and riparian (streamside) forest, and upland hardwood forest. The riparian area is of particular significance as part of the Kent Falls Brook watershed; its 2800 linear feet of brooks




contain side channels, pools and chutes that harbor wild brook trout. Turtles and mink are among the fauna inhabiting this area and at least one Cooper's hawk, a State Threatened Species, has been spotted there. The upland hardwood forest is characterized by oak, maple, ash, hickory and tulip poplar, and provides a protected habitat for such woodland animals as deer, squirrels, covote and cottontail rabbits. This forest also features one of the more scenic parts of the Preserve: a glade containing an exceptional old stand of paper birch and groundstory of lowbush blueberry. Game trails, old wood roads and crumbling stone walls wind through the forest. The Warren Land Trust is pleased to have the opportunity to protect this diverse, attractive and ecologically significant parcel.

# Teamwork Underscores Our Submission of Accreditation

Three and one half years ago, the Warren Land Trust embarked on he very ambitious challenge of seeking accreditation by the National Land Trust Accreditation Commission. Typically, a task of this magnitude requires a multi-faceted Board of Directors, deep financial reserves, and the extensive support of contractors, consultants and volunteers.

The Warren Land Trust is blessed to have an active Board of fourteen volunteer members with diverse talents of legal expertise, clear understanding of the town's natural surroundings, fund-raising acumen, and conservative financial management.

Under board member Dan Hulseberg's organization and coordination, the Board as a whole has contributed generously toward accomplishing our goal. We successfully completed all Pre-Application requirements in January 2014, and are now quickly approaching the April deadline for submission of our formal application -- which includes a massive binder full of documentation, as well as supplemental attachments and appendices responding to questions on all aspects of our standards, practices and procedures. This binder, once completed, will be replete with governance policies, financial records, documentation of all properties under the aegis of the Warren Land Trust. The Board will then be interviewed by the Commission, with a range of questions about our past history, our management of fee properties and easements, our relationship with the town, and our projections for the next few years.

Without question, this exercise has been challenging, at times tedious, but unequivocally worthwhile. It has been a wonderful opportunity to memorialize our accomplishments and contributions to the community as well as to clarify our vision and mission. We recognize that we have been entrusted with a tremendous responsibility, and we are honored to be able to render a gift to be enjoyed by future generations of Warren residents and visitors alike.

### Join the Annual Town Clean-Up!



The WLT recently received a \$2.000 grant from the CT Land Conservation

Council. This grant has enabled WLT to work with the Brawly Consulting Group to establish effective management plans that will guide the WLT to fulfill its stewardship responsibilities.

### Management plans include:

WLT Receives Grant

- A description of the conservation values of each parcel
- A summary of any restrictions that came with the property or were placed on the property after the WLT took ownership
- A description of the potential threats to the conservation values or areas of special concern (i.e. invasive species, neighbor encroachment, unauthorized access)
- Overall management goals and key actions
- A timeline for planned activities and for regular inspections of the property

Strong stewardship practices will insure the protection of the conservation values of WLT lands forever.

### Warren Land Trust Applies For National Land Trust Accreditation

As you have read in this and previous newsletters, the Warren Land Trust is pleased to announce that it is in the process of seeking Accreditation from the National Land Trust. The land trust accreditation program recognizes land conservation organizations that meet national quality standards for protecting important natural places and working lands forever. The Land Trust Accreditation Commission, an independent program of the Land Trust Alliance, conducts an extensive review of each applicant's policies and programs. The Warren Land Trust's Application for Accreditation will be filed on April 23, 2014.

The Commission invites public input and accepts signed, written comments on pending applications. A public comment period is now open. Comments must relate to how Warren Land Trust complies with national quality standards. These standards address the ethical and technical operation of a land trust. Comments on the Warren Land Trust's application will be most useful by June 1.

The accreditation process is a rigorous independent analysis of the Warren Land Trust's programs and practices. Accredited land trusts are able to display a seal indicating to the public that they meet national standards for excellence, uphold the public trust and ensure that conservation efforts are permanent.

### 2013 Annual Meeting

The Warren Land Trust's 2013 Annual Meeting was held on November 16, 2013 at the Academy. We had a record turnout of Warren residents attend the meeting which was very exciting.

The WLT had a very busy year seeking National Accreditation along with participating in numerous community events: the Warren Fall Festival, Trails Day, Town Clean-up. The WLT also hosted two new events, WLT Wine-Tasting Dinner and the WLT Fall Picnic at Angevine Farm. The WLT announced that it was cooperating with the Kent Land Trust to help them purchase a 253-acre former Girl Scout property, known as Camp Francis, 70 acres of which are in Warren.

We also reported on our activities in land management and fundraising as well as providing a financial report for the fiscal year ending June 30, 2013. Dorothy Maier and Laura Moore Brown were re-elected as Directors for a three year term, and Jamie Browne was elected as a new Board Member. Craig Nelson, after being elected as Warren's Town Selectman, was designated as an Ex-Officio Board Member.
